INVITATION FOR BIDS

Sealed bids for the 2016 STREET IMPROVEMENT PROJECT – PHASE 3 as described below will be received at the office of the Village Clerk, Janet Sirabian, Buffalo Grove Village Hall, 50 Raupp Boulevard, Buffalo Grove, IL, 60089 until 10:00 A.M., local time, May 19, 2016, at which time all bids will be publicly opened and read aloud. Sealed envelopes are to be marked “Sealed Bids for Village of Buffalo Grove 2016 STREET IMPROVEMENT PROJECT – PHASE 3”.

Specifications, Bids, and Contract Documents may be obtained from Gewalt Hamilton Associates, Inc. Project Engineer, 625 Forest Edge Drive, Vernon Hills, Illinois 60061, (847) 478-9700. A \$25.00 non-refundable deposit is required.

Bid for construction of the 2016 STREET IMPROVEMENT PROJECT – PHASE 3 will include, but is not limited to, the following major work items: roadway rehabilitation including removal and replacement of concrete curb and gutter, hot mix asphalt pavement removal & resurfacing, hot mix asphalt pavement patching, hot mix asphalt binder and surface placements, and parkway restoration.

All bidders must submit with their bid a resume of similar projects performed; enumerated as to location, type of work, approximate completion date, and supervising engineering or architectural firm. Additionally, all bidders must submit with their bid a list of equipment owned, or available to them, for the efficient pursuance of the project and a list of subcontractors to be used on the project.

This work is subject to the wage provisions of the Illinois Prevailing Wage Act. 820 ILCS 130/0/01 et seq. and the Illinois Substance Abuse Prevention on Public Works Projects Act. 820 ILCS 265/1 et seq relative to prevailing wages of laborers, mechanics, and other workers employed in any Public Works as amended by Public Acts 86799 and 86693.

This is a calendar day contract.

Bid security in the form of a Bid Bond, Bank Cashier's Check or Certified Check for the amount specified in BLRS Special Provision for Bidding Requirements and Conditions for Contract Proposals contained in the IDOT “Supplemental Specifications and Recurring Special Provisions” made payable to the Village of Buffalo Grove shall accompany the bid.

The Village reserves the right to reject any and all bids and bidders and to waive all technicalities. All bids submitted shall be valid for a period of one hundred twenty (120) days. The Village reserves the right to award to any Bidder based on negotiation with any and all Bidders after receipt of bids.

State of Illinois, Department of Transportation, Contractor Pre-Qualification and Subcontractor Pre-Qualification/Registration is required.
